Juror Empathy and Race (Tennessee Law Review)

Increased social and occupational interaction between races, as well as more frequent observation of people of different races in popular culture, has increased the likelihood of interracial empathy. By leaving intact the power of the jury to unconsciously discriminate, the Supreme Court in McCleskey encouraged trial attorneys to battle, in their own self interest, against racial bias.
